9:05 NRCS Updates Locally led Conservation Customer Feedback Questionnaires are due to Marybeth in August (plan to analyze results in at a Board Meeting in early September). Marybeth distributed a model questionnaire and offered that WNRCD can customize it. The questionnaires should help describe the top resource concerns in the district and practices you would like to see implemented and prioritized by NRCS. The new system no longer allows Districts to distribute 250 points in the ranking system, rather Districts share their general priorities which NRCS will take into account as they make funding choices. The survey can be completed by anyone in the District. They do not need to be farmers and do not need to be landowners. We can ask partners for feedback and incorporate into our ag work group. It is permissible to solicit feedback in an online fillable form. Goal for participation: 50

Round 3 of funding is closed. There were many more applicants for funding than money available. A request has been made to national for \$2.2 million additional to fund a few more applicants. CSP applications are also closed (many more applicants than funding available).

Discussion about manure pit engineering specs in the face of climate uncertainty (currently they must be designed to store 180 days of manure). Pits over a certain size require a dam permit.
