Nutrient Management Plans

The WNRCD can help you write your own Nutrient Management Plan; At NO COST to you.

To assist small farms in the development of Nutrient Management Plans (NMPs) a partnership was formed between the Vermont Association of Conservation Districts, the 14 Natural Resource Conservation Districts in Vermont, UVM Extension and NRCS. The purpose of this program is to improve water quality by reducing phosphorus and other nutrient loading from small livestock farm operations in the Lake Champlain Basin and beyond. The program is supported through an agreement with the USDA NRCS, as well as through contributions from the partner organizations.

Great news: By writing your own NMP you can:

- ~ Understand the nutrient needs of your soil.
- ~ Learn how to improve water quality and soil health on your farm.
- ~ Learn how to best use your manure on your land.
- ~ Meet a requirement of the state's Required Agricultural Practices

The Process to achieve your own NMP

- Sign and return the attached Application & Information Release form to: Winooski NRCD 300 Interstate Corporate Center, Suite 200 Williston, VT 05495
- 2. Establish records with the Farm Service Agency (FSA) if not already completed.
- 3. Assist with collecting soil samples on fields.
- 4. Discuss production and conservation goals with a Technical Service Provider who will collect farm information needed for the NMP class and to prepare you Land Treatment Plan.
- 5. Attend the six Nutrient Management Plan classes provided by the UVM Extension. These classes are held in winter at sites throughout the state.
