WINOOSKI NATURAL RESOURCES CONSERVATION DISTRICT  
NOMINATING PETITION TO BE PLACED ON BALLOT FOR THE OFFICE OF SUPERVISOR

**Instructions for Candidate Supervisor:** Eligible candidates include any person who lives within Winooski District boundaries. Winooski District boundaries include all of Chittenden and Washington counties and the towns of Orange, Williamstown, and Washington (see map below). Twenty-five signatures from Winooski District landowners are required for candidates to be put on the election ballot. There is no minimum parcel acreage or lot size for a valid signatory, any and all landowners living within Winooski District boundaries may sign in support of your petition. Complete the top of page 3 with your full name, address, and county of residence and circulate. All signatures need not all be on the same petition; two (2) or more petitions may be circulated--so long as signatures on all petitions total twenty-five (25) or more and each petition circulated has your information on it (see top of page 3). Return completed petitions and your contact information (email and/or phone) to the Winooski District offices by **November 10, 2020**.

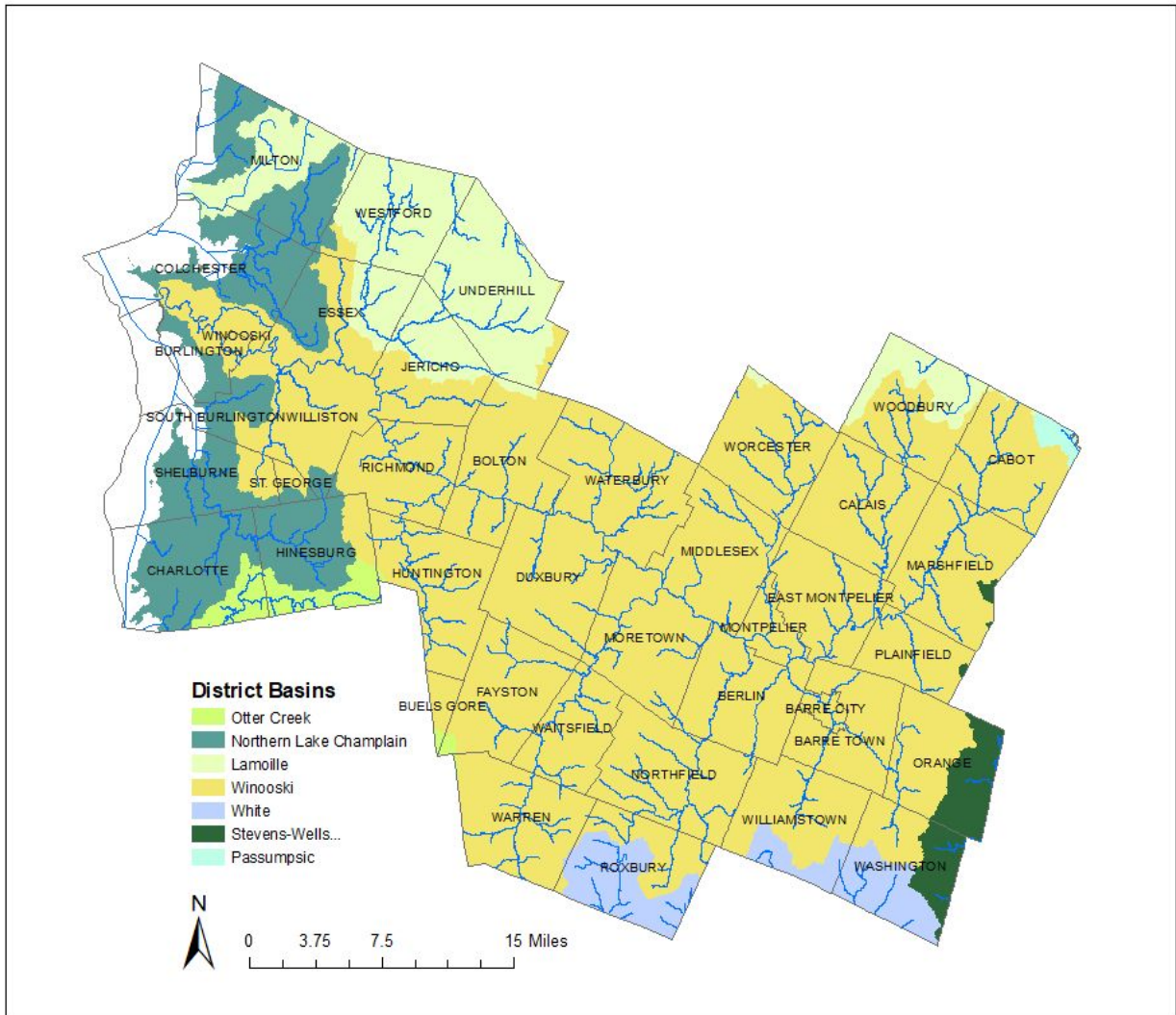
