#### 9:17 NRCC Update - Rick Hopkins

- Had a meeting on February 8, 2023 after a longer hiatus with the previous meeting being in November 2022
- Approved budget for FY23
  - \$2.9 Million
- Increased funding to \$362,000 divided by each district  $\rightarrow$  Historically has been at ~\$112,000 each year
  - Winooski used some of the requested capital funds to purchase new computers, printer, monitors, additional tech needed for remote work, and tree planting supplies (shovel, portable water pump)
    - Have ~\$1,200 left in funds. Started with \$5,500
- FY24  $\rightarrow$  Council put in request for \$3million
  - If fully authorized  $\rightarrow$  Over \$1 million to be split between all districts
- Council now has district manager reps (Cory Ross and Sarah Damsell)
  - Gives council new representation on what districts actually want
  - New discussion on increasing pay to keep staff longer and compensate them fairly
- Jill Arace is forming a board for VACD
  - 1 supervisor to represent each district
  - 8 out of 14 districts are interested in creating a board so will move forward with request
  - Strong interest from Nancy to be the representative for Winooski on this VACD board
- Question was asked during the board meeting on the future of the DEC block grants?
  - Rick mentioned that no further discussion was had at NRCC meeting
  - Looks like the Clean Water Service Providers will be the new route of funding
